# April 2023 NPA 709/879 J-NRUF Report to the Canadian Steering Committee on Numbering (CSCN)

## 1. Purpose of the J-NRUF

Section 9.1 of *Canadian NPA Relief Planning Guideline*, Version 7.0 dated 14 September 2018 states that:

..., a Jeopardy Condition exists when any NRUF or other CO Code assignment data indicates that the projected demand for CO Codes will exceed the quantity of CO Codes available for assignment before the date that relief is scheduled to be implemented.

In accordance with the *Canadian Numbering Resource Utilization Forecast (C-NRUF) Guideline*, Version 5.1 (the C-NRUF Guideline), approved by the Canadian Radio-television and Telecommunications Commission (CRTC) in Telecom Decision CRTC 2015-166 dated 29 April 2015:

When an NPA is declared by the CNA to be in a Jeopardy Condition, the CNA initiates a J-NRUF to obtain actual and forecast data to assist in the monitoring and management of the limited numbering resources available for assignment until relief is provided. The J-NRUF is normally conducted on a quarterly basis from the date that the Jeopardy Condition is declared by the CNA until three months of when relief is implemented.

On 28 February 2023, the CNA advised CRTC staff that, based on the January 2023 General Numbering Resource Utilization Forecast (G-NRUF) submissions, the NPA 709/879 Projected Exhaust Date (PED) had advanced to November 2024. Accordingly, the NPA had entered a Jeopardy Condition.

Based on the January 2023 G-NRUF results published on 29 March 2023, the Canadian Numbering Administrator (CNA) concluded that a Jeopardy Condition existed in NPA 709/879 which covers the geographic area of Newfoundland and Labrador.

On 13 April 2023, CRTC staff directed the CNA to apply the following measures:

- Freeze all central office code assignments in area code 709/879 based on the January 2023 G-NRUF carrier submissions to 1 January 2024 forecasted quantities; and,
- Conduct area code 709/879 Jeopardy Numbering Resource Utilization Forecasts (J-NRUF) at the NPA level of detail.

The Jeopardy Contingency Plan dictates that the CNA requests two versions (two separate worksheets – Form 1 and Form 2) of the J-NRUF input from all current and prospective CO Code Holders quarterly until three (3) months before relief is provided. The forecasted quantities in Form 1 should be the same as or

lower than the January 2023 G-NRUF carrier submissions up to the 1 January 2024 forecasted quantities. CO Code Holder forecasts may reflect an increase in demand in the period after the Relief Date. Form 2 will reflect the actual demand required by the CO Code Holder's current business plan and will be provided for information purposes only.

The CNA has prepared this J-NRUF report in accordance with the C-NRUF Guideline.

## 2. High Level Summary

The CNA has rationalized the April 2023 NPA 709/879 J-NRUF input from various Telecommunications Service Providers (TSPs) and the variance from previous inputs appears reasonable.

The April 2023 NPA 709/879 J-NRUF Form 1 PED has moved out to March 2025, due to business plan changes by some TSPs.

The April 2023 NPA 709/879 J-NRUF Form 2 indicates a PED of November 2024 if there were no CO Code assignment restrictions.

#### 4. J-NRUF Assumptions

The assumptions used for the April 2023 NPA 709/879 J-NRUF are the assumptions that were provided on 12 October 2022 to the CNA by the Canadian Steering Committee on Numbering (CSCN) for conducting the January 2023 NRUF.

## 5. Summary of Challenges Encountered During the J-NRUF Process

Most TSPs continue to rely on the CNA to remind them of the due date. The CNA started contacting companies on 21 April 2023. Despite this initiative, some J-NRUF submissions were incorrect.

Most CO Code Holders were confused about the Code restrictions and difference between the Form 1 and Form 2 J-NRUF worksheets.

#### 6. Conclusion

In accordance with Section 4, Item 6h) of the C-NRUF Guideline, the CNA has conducted assessments, sought clarification and/or explanations from various TSPs to reconcile 2023 growth with current and historical forecasts to determine whether the April 2023 J-NRUF results are reasonable.
