Subject: Recommendation to follow ATIS NPA Allocation Plan and Assignment Guidelines for New

Canadian NPAs

Dear Sir,

The purpose of this letter is to propose a new direction relative to the letter that was sent on 20 December 2023 concerning the request to have additional Numbering Plan Area (NPA) codes reserved for future Canadian Geographic and Non-Geographic use.

Since sending that letter, discussions have taken place among North American Numbering Plan Administrator (NANPA) staff, Canadian Numbering Administrator (CNA) staff, CRTC staff and CSCN participants on the topic. Particularly, it was noted by NANPA staff that Canada could elect to follow the Alliance for Telecommunications Industry Solutions (ATIS) Industry Numbering Committee (INC) NPA Allocation Plan & Assignment Guidelines, whereby any member of the North American Numbering Plan (NANP) could reserve NPAs for future use before exhaust of a specific Geographic NPA Complex or Non-Geographic NPA.

During the most recent CSCN plenary meeting in October 2024, the CSCN agreed that Canada should opt to forego negotiating a set reservation pool as Canada had done previously and elect to use the procedures within the ATIS INC NPA Allocation Plan & Assignment Guidelines. The CSCN believes that the ATIS guideline already presents a process for Canada to request additional NPA codes subject to some possible clarifications.

The CSCN recommends that Canada follow the on-demand approach to acquire new NPAs as detailed in the referenced ATIS guideline. The CSCN intends to work with NANPA to update the ATIS NPA Allocation Plan and Assignment Guideline as appropriate to be in alignment with this approach. This may also require the CSCN to file an update to (or eliminate) the Canadian Adjunct to the ATIS NPA Allocation Plan and Assignment Guideline as appropriate.
